The Yankton County Welfare Report for December 2015 included 10 contacts, 7 notices of hospitalization, and 3 medical bills for the County Jail.

ROD: The Register of Deeds report from December 2015 showed collection of \$13,356.40 in regular fees; \$10,774.50 in transfer fees; and \$3,974.00 in copies revenue.

Veterans Office: VSO Michael McDonald's December 2015 report showed 81 contacts on behalf of veterans last month. McDonald also coordinated transportation of 18 veterans (eight trips) to appointments at the VA Hospital in Sioux Falls.

EMS: Emergency Medical Services monthly report for December 2015 listed 161 total calls. Year to date Yankton County EMS has collected \$748,695 and spent \$901,659.

Auditor/Treasurer: The Auditor's Monthly Settlement with the Treasurer as of December, 2015 showed Total Cash of \$6,850,465.08. The General Fund was \$4,935,705.66; Special Funds were \$1,182,391.77; and Trust and Agency Funds were \$732,367.65 adding to a Grand Total of General Ledger Cash and Investments of \$6,850,465.08. A detailed report is on file with the County Auditor. Joint Cooperation Agreement with Planning and Development District III.

Zoning: The year end staff report for Planning and Zoning was presented by Denise Wubben.

Health Nurse: Julie DeYonge, RN, provided the 2015 fourth quarter report from the S.D. Department of Health and Yankton County WIC Office. Also inquired if the board was interested in supplying the Hepatitis B vaccination and CPR classes to county employees.

Action 1628C: A motion was made by Bodenstedt and seconded by Kettering to accept the S.D. Department of Health and Yankton County WIC Office Report for October, November and December 2015. All present voted aye; motion carried.

Bridges: Highway Superintendent Brian Gustad appeared before the board to present the bridge project changes on the Statewide Transportation Improvement Program (STIP) plan. Dan Johnson from Johnson Engineering appeared before the board to present two proposals, option A and option B, to provide engineering an channel surveying services for placement of riprap on structure 68-134-120, in accordance with the recent permit obtained by Yankton County from US Army Corps Engineers. Option A would be a lump sum fee of \$30,000 and completed in time for the 2017 James River high water. Option B would be a lump sum fee of \$19,000 and completed in time for the 2016 James River high water.

Action 1629C: A motion was made by Kettering and seconded by Bodenstedt to replace structures #68-217-030 and #68-232-097 with structure #68-043-014 in the Transportation Improvement Program (STIP). All present voted aye; motion carried.

Action 1630C: A motion was made by Kettering and seconded by Bodenstedt to accept option B for structure #68-134-120 on 303rd St. All present voted aye; motion carried.

DOT Loan: Toby Morris from Dougherty & Company LLC appeared before the board to give an overview of the DOT loan claims for Napa Junction Project.

Strategic Planning: Gregg Henderson from District III Planning and Development appeared before the board to discuss the process for the board's yearly strategic plan for 2016. Commissioner Bodenstedt stated she would like the county department heads to offer their ideas and concerns. Mr. Henderson stated he will send a questionnaire for the offices to complete.

Acquisition: Commissioner Kettering reported to the board about acquiring the right-of-way land on the new road to be built for the Napa Junction Projec. There will be approximetly 12 landowners involved. States Attorney Rob Klimisch stated that Robert Gehm would perform the appraisal on the property in question, at the cost of \$2,000.

Action 1631C: A motion was made by Kettering and seconded by Bodenstedt to have Robert Gehm perform the appraisal process for the land for Napa Junction Project. All present voted aye; motion carried.

Action 1632C: A motion was made by Bodenstedt and seconded by Kettering to recess the regular session at 5:15 and convene in Executive Session to discuss personnel matters. All present voted aye; motion carried.

Action 1633C: A motion was made by Kettering and seconded by Bodenstedt to adjourn executive session at 5:30 pm and reconvene in regular session. All present voted aye; motion carried.

Chairman Woods reported no action would be taken as a result of the executive session.

Action 1634C: A motion was made by Kettering and seconded by Bodenstedt to have items from the Sheriff's office declared surplus. All present voted aye; motion carried.

Action 1635C: A motion was made by Kettering and seconded by Bodenstedt to adjourn. All present voted aye; motion carried.
